OUR PRIVACY POLICY

Protecting your private information is our priority. This Statement of Privacy applies to solizaevents.com and Soliza Weddings & Events and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Soliza Weddings & Events include solizaevents.com and Soliza Events. The Soliza Events website is a Event planning services site. By using the Soliza Events website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Soliza Events may collect personally identifiable information, such as your:

- -First and Last Name
- -Mailing Address
- -E-mail Address
- -Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Use of your Personal Information

Sharing Information with Third Parties

Soliza Events does not sell, rent or lease its customer lists to third parties.

Soliza Events may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Soliza Events, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Use of Cookies

- •Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- ·Comply with the California Electronic Communications Privacy Act;
- •Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent:
- ·Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- ·Comply with an existing legal obligation; or
- ·Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
